RATE SCHEDULE A
Single-Phase General Service

APPLICABILITY

This schedule is applicable for year-round service to single-phase residential, small commercial and public building consumers. Service under this schedule is subject to the Cooperative's established rules and regulations.

TYPE OF SERVICE

Service under this schedule shall be single-phase, 60 hertz, at available secondary voltages.

MONTHLY RATE

Basic Facilities Charge: \$ 26.00 per month

Energy Charges:

First 1,500 kWhs per month	11.63¢ per kWh
Next 2,500 kWhs per month	10.47¢ per kWh
Next 4,000 kWhs per month	9.32¢ per kWh
All kWhs over 8,000 per month	7.48¢ per kWh

MINIMUM MONTHLY CHARGE

The monthly minimum bill shall be the Basic Facilities Charge.

MINIMUM ANNUAL CHARGE

Service under this schedule is intended for consumers requiring service on a year-round basis. In no event shall the minimum annual charge be less than twelve times the applicable Basic Facilities Charge.

Consumers requesting Service to be reconnected, which has been disconnected for less than twelve months, shall be responsible for the greater of:

1. The monthly minimum, as determined above, times the number of months the service was disconnected; or
2. The Cooperative's current reconnection charge.

WHOLESALE POWER COST ADJUSTMENT CHARGE

The above kWh charges may be increased or decreased by 0.001 cents per kWh, or major fraction thereof, adjusted for line losses and North Carolina gross receipts taxes, by which the Cooperative's cost of purchased power, on a per kWh basis, exceeds or is less than the Cooperative's base cost of power, as prescribed in the Wholesale Power Cost Adjustment Rider.

SSI - SUPPLEMENTAL SECURITY SERVICE

For customers receiving Supplemental Security Income, the rate for the first 600 kWh shall be 11.34 cents per kWh.

REPS AND EE ADJUSTMENTS

The consumer's monthly bill shall also include the Renewable Energy Portfolio Standard (REPS) and Energy Efficiency (EE) adjustments based upon the revenue classification of the account. The revenue classifications and monthly charges are shown in the Cooperative's Renewable Energy Portfolio Standard and Energy Efficiency Riders

TAXES

North Carolina Sales Tax will be added to the rate and shown on the bill.

TERMS OF PAYMENT

The above rates are net. Bills are due and payable within 25 days of the billing date shown on the bill. In the event the current monthly bill is not paid, it shall be considered delinquent, may be subject to a late fee, and service will be suspended in accordance with the Cooperative's established Service Rules and Regulations.
