*The undersigned applicant hereby applies for membership in, and to receive electric service from Surry-Yadkin Electric Membership Corporation (the "Corporation"), and agrees to the following terms:*

- 1. The Applicant will pay the Corporation such service security deposit and such connection fee for additional service as may be required by the Corporation as is provided for by the Board of Directors acting under policies of general application.*
- 2. The Applicant will purchase from the Corporation all electric energy used on the premises and pay therefore at the rates fixed by the corporation in accordance with the bylaws, certificate of incorporation and the law.*
- 3. The Applicant's premises shall be wired in accordance with the bylaws of the Corporation and shall pass the inspection required by law.*
- 4. There will be no liability on the part of the Applicant for any debt or liability of the Corporation.*
- 5. Upon acceptance of this application by the Corporation, the Applicant and the Corporation will be bound by the certificate of incorporation, the bylaws of the Corporation, all rules and regulations of the Corporation and the law, and rate schedules established pursuant thereto for electric service.*
- 6. As a further consideration hereto the Applicant agrees to grant a reasonable permanent right-of-way, overhead or underground, on the premises owned by the Applicant, without compensation, for the furnishing of electric service to the Applicant or other member of the Corporation.*
- 7. The Applicant agrees to pay **finance charges** on any account balances unpaid more than 25 days after the billing date, not to exceed one and one-half percent (1 ½%) per month (18% APR). Further, the Applicant agrees to pay reasonable attorney fees and/or court cost allowed by law to collect an unpaid balance.*
